

SkiErg Sprints 2022 Giveaway Rules

Clubs can win a SkiErg® ski trainer with floor stand

The 2022 SkiErg® Sprints takes place between November 10-13, 2022. Clubs or teams of at least thirty participants will be eligible for the chance to win a SkiErg® ski trainer and floor stand (together valued at \$1070, the “Prize”), which will be shipped to two winners free of charge. To be eligible to win, clubs must timely submit 30 or more results from a SkiErg® Sprint event held at their facility during the event, as set out below. Winners will be selected in a random drawing and two Prizes will be awarded and shipped to two eligible winners.

How to enter

To be eligible for the drawing, clubs or teams must send their team member names, date of birth, and race results by email to info@concept2.com no later than November 14, 5:00 pm ET. Eligible entrants must use the [SkiErg® Sprints Event Entry Form](#) for their submission.

Late submissions cannot be accepted. All results MUST be submitted by November 14, 2022 5:00 pm ET to be eligible to win.

Eligibility

Open to clubs or teams of the fifty United States and D.C. Team members of the SkiErg Sprints may include Concept2, Inc. (“Concept2”) employees or their household members if they are a team or club member of the entrant. Residents outside the United States are not eligible to enter or win. Limit one entry per club or team.

Drawing

A random drawing will be conducted on or about November 15, 2022 by Concept2 to select the winners from among all eligible entries received. Odds of winning depend on the number of entries received.
